

**WILMINGTON BOARD OF ABATEMENT
MONDAY, JANUARY 30, 2012 AT 5:30PM
MINUTES OF MEETING**

The Wilmington Board of Abatement convened at 5:30pm on Monday, January 30, 2012 in the Twin Valley High School Cafeteria.

IN ATTENDANCE: A quorum was achieved with 13 out of 20 members present.
