1. **Primary area of focus** - define the main corridor – approximately:

Northern end (Snow lake)

Southern End (airport)

Western edge (Coldbrook Rd)

Eastern edge (Rt 100)

2. Trail expansion

- a. Tannery Wildlife Kelly did not invite Edie Mas to meeting. Mike Purcell said he may see her and ask.
- b. Deer Creek land tax sale the town bought that parcel at the tax sale and there is one year for owners to pay back taxes.
- c. There was discussion about the Eugene Ettlinger parcel (Little Flower) that is for sale about 50 acres and the opportunities it would open up.
- d. Andy had good news from the USFS. The trailhead project on Handle Rd is now on the USFS Schedule of Proposed Action. There could be a decision by Oct 2017 and implementation by May 2018. Andy warned us that he has been working on this for a very long time and has learned that it could take longer. But great work just to get on the list!

 - iii. 501c3
 - iv. Marketing
 - v. Maintenance
 - vi. Permitting

4. Main objectives/strong trail system attributes

- a. Connecting trail (multi-use, non-motorized) from Dover to Wilmington.
- b. Parking in a central location
- c. Core area of focus that has access for beginners and expert users alike
- d. Visually marked trails user friendly
- e. Find a way to link all lodges and businesses together
- f. Smooth and improved path must be sustainable

5. VMBA

a. Tim Hunt – reached out to Tom Stuessy, Executive Director at VMBA. Report to group. Tom would like to see this group as an arm of VMBA. He would like to come down and talk to us as a group. He would like to see at least 5 people who are vested in the group. Are we there yet? Tabled until next meeting but we did discuss possible leaders for the group (3d).
