

**TOWN OF WILMINGTON**

**BUZZY TOWNE PARK HOURS OF OPERATION ORDINANCE**

**WHEREAS:** upon investigation, the Board of Selectpersons have learned that certain persons have been using the Buzzy Towne Park in late evening hours in violation of the Town of Wilmington's Open Container Ordinance and possibly in violation of other laws;

**NOW, THEREFORE,** it is hereby ordained by the Selectpersons of the Town of Wilmington in the exercise of their police power as follows:

**Section 1:** It shall be unlawful for any person to enter the Buzzy Towne Park between the hours of 10 P.M. and 5 A.M.

**Section 2:** Upon first obtaining a written permit, any publicly recognized organization or organized group, or family group, may be exempted from the provisions of Article I of this ordinance for an event. Any person or organization desiring to obtain such a permit shall make written application therefor, to the Board of Selectpersons, not less than ten (10) days prior to the date of the desired permit. The granting or withholding of said permit shall be within the sole discretion of the Board of Selectpersons and a record of such request and the decision thereon, shall be recorded in the minutes of the Selectpersons' meetings.

**Section 3:** A person who violates this ordinance shall be punishable by a fine of not more than five hundred dollars (\$500.00) or imprisonment of not more than one (1) year.

**Section 4:** If any provision of this ordinance or the application thereof to any person shall be held by any court to be invalid, such holding shall not affect the validity of the remainder of this ordinance and to this end the provisions hereof are declared to be separable.

This ordinance shall be entered into the Selectpersons' minutes, shall be posted in at least five (5) conspicuous places within the Town and published in the Green Mountain Courier and the Deerfield Valley News, newspapers circulating in this town, not more than fourteen (14) days following the date specified below when this ordinance is adopted.

This ordinance is hereby adopted by the Board of Selectpersons of the Town of Wilmington on this 16th day of June, 1993 and shall, unless a petition is filed as provided by law, become effective upon the expiration of sixty (60) days after said date.

Citizens have the right to petition for a vote on this ordinance

at an annual or special town meeting as provided in Section 1973,
