The school board was favorable and board member Dennis Richter emailed the Town Clerk to ask her to look into the process of holding the election at DVES. It is the BCA's authority to make the decision on location of polling places.

The BCA discussed potential costs of moving election equipment and putting down tarps on the DVES gym floor. What is the capacity of the room and are there enough chairs. Could the Moover bring people to the meeting to reduce parking issues. The voting would need to be set up in the cafeteria, while the floor meeting would be in the gym.
