3. Discuss grant possibilities:

Gretchen presented two possible grants we can pursue.

-Eco-system restoration-At present we have only last year's information. New information will be presented at a webinar on May 4 from 10:30-12:00 about an upcoming RFP. It is somewhat involved. Cheryl and Craig will participate in the webinar.

-VT watershed education/outreach planning on ground projects (i.e. rain gardens, native trees and shrubs, dam removal, instream habitat improvement, flood resiliency)

BDCC Chris Saunders from Leahy Office Blueprint to Rebuild America's Infrastructure Resilient communities Entire U.S.- 25 billion dollars Gretchen will find out more about this.

Discussion of cost to PC for grant writing assistance and monies available. The budget ends June 30. We are \$420 over budget for present FY Next FY budget is \$4795.00 which includes \$4145.00 projected dues for WRC.

WRC will generally provide planning grant help for free. For a flood resiliency plan we would have to pay them.

Another municipal planning grant is not coming up until next winter.

4. Discuss Solar Project

Will King from Solar Sense presented information on solar panels and preferred sites

Next steps will be to determine if the town wants to pursue this.

Ann suggested the Planning Commission come to the Select Board to lay it out once we have a better sense of Act 174 and the options for the town. The Planning Commission will follow-up with Will King in four weeks. GMP has maps that we can access to look over possible preferred sites.
