The meeting was called to order by Nicki at 7:04

**Secretary's Report:** Motion was made by Heather and seconded by Deb to approve the minutes from the April 4, 2019 meeting. Motion passed 7-0.

Nicki also had a wooden etching of the main intersection in downtown Wilmington, done by a new process at John McLeod's. Everyone liked it and thought it would be a good memorabilia item to sell. No decision was made.

Deb reported that she has set up an email account with the address being [wilmingtonohw2020@yahoo.com](mailto:wilmingtonohw2020@yahoo.com). She shared the password with the committee members and has volunteered to monitor the emails that come in and distribute them to the appropriate people.

Mailing List: Deb met with Sharon and has the database of names thru 2018. Unfortunately, there are many years of names 2011-2018 without addresses. She has not yet received the alphabetized list from Mary. Nicki will put out an appeal on email/facebook asking for address updates.

Nicki wondered if anyone knew of a member of either the Readsboro Fire Department, the Halifax Fire Department or the Rotary and could check to see if they were interested in doing the barbecue. Heather volunteered to contact Halifax and Julie will check with Readsboro.

Nicki announced that the Nito Family/ Business has volunteered to take on the Ice Cream Social.

Largest Tree will be decided by Boyd Farm, Wimmelman & Sons and Black Diamond working together

Nicki and Deb went to the Wilmington Works meeting and reported that they are willing to help us in any way they can.

Carl reported that Cliff Duncan is also willing to help out where he can.

Meg Stoloff will be the interface with the businesses in town so that they will know what is happening.

Carl wondered if we need a contingency plan for bad weather. Nicki mentioned that in 2010 we shared the expense of a large tent with the Farmer's Day Fair committee. At this point we do not know if that same arrangement would work for 2020. Perhaps the Old School Building could be used if needed.

D.J. said that they had gotten tents from Green Mountain Tent Company in Newfane and that they were easy to work with.
