Discuss and approve the report for the proposed Zoning updates

A copy of the report to be sent to the Select Board was reviewed and discussed. In the first paragraph references to 'Articles" will be changed to "Section." John made a motion to approve the report as corrected Tom seconded. In favor: Cheryl, Tom, John, Meg, Angela Opposed: none

Discuss and approve the report on the proposed Flood and Fluvial Erosion Regulations

The report was discussed and required questions from the State were answered. 1. The proposed regulations conform to the to goals and policies stated in the Town Plan.

2. In the Town Plan adopted on October 22, 2018, goal 11, policies 1 and 2. There is no effect on availability of safe and affordable housing.

3. No planned community facilities are affected by this amendment.

Discuss the Lake Raponda Watershed Grant

John attended a meeting on the Lake Raponda Watershed Grant. Jack Widness had requested a representative from the Planning Commission attend. The grant seeks to have Lake Raponda designated as a VT ANR Outstanding Resource Water Status. The designation would put restrictions on building large projects such as a Water Treatment Plant around the lake. Residential building would not be affected. There is no contribution from the Town. John thinks the application falls in line with Town Plan goals.

Tom wondered what affect possible future paving would have on the designation. None. Any affect on water quality would be the onus of the Lake Raponda residents.

Angela asked the amount of the grant request. \$3480.00 the application is due in the fall. Scott Tucker sent a letter of support for the application. The application is to be able to put data together. The planning Commission has no responsibility.

Cheryl noted there is only one river corridor at the north end. No official letter of support from the Planning Commission is needed.

Discuss and approve a letter of support for an OSEC grant

Meg explained the grant Economic Development grant. Specific points include continuing renovations on the Old School community Center, specifically bathrooms in public areas. It is a 1-1 matching funds (\$25,000) using monies to match from those already raised.

Planning Commission could write a letter of support since it falls in line with the Town Plan. No town funds will be used. There is no politicalization.

Tom made a motion that Cheryl sign the proposed letter in support of the grant. John seconded. In favor: Cheryl, Tom, John Meg, Angela
