## LETTER OF INTENT TO PARTICIPATE IN THE MUNICIPAL ROADS GRANTS-IN-AID PROGRAM

that the municipality will:

- Construct one or more road best management practices (BMPs) to bring connected road segments into full compliance with Municipal Roads General Permit (MRGP) standards, to be completed by June 30, 2021.
- Construct the road BMPs on hydrologically connected road segments roads that drain directly into surface waters (streams, rivers, ponds, lakes and wetlands). Contact your Regional Planning Commission or refer to the Vermont Department of Environmental Conservation (DEC) map layer for *hydrologically-connected* municipal roads in Vermont. This map layer is available at: <u>http://anr.vermont.gov/maps/nr-atlas.</u>
- Consult with the Regional Planning Commission prior to construction of the BMPs to conduct a required site visit and verify the appropriate location of the connected road segment and BMP(s) to meet MRGP standards.
- Post a Clean Water Project sign during construction (select projects only).
- Provide a minimum of 20% local match (in-kind and/or cash). Match can include quantified in-kind contributions such as transportation, municipally-owned road equipment, crew labor, municipal staff time and other costs directly related to the BMP construction project as part of this program. Funds from other federal or state grant programs or local match for those other federal and state grant programs cannot be included as match.
- Work with the Regional Planning Commission to compete all reporting and invoicing requirements.
- Comply with the MRGP before requesting reimbursement from the State for construction and equipment costs. Full compliance with the MRGP includes full payment of MRGP fees, required MRGP forms and Annual Planning Report.

Dear Town of Wilmington Selectboard:

Our Southeastern Vermont communities have been carefully navigating the upheaval, uncertainty, and impacts of the COVID-19 crisis with modest degrees of success. From local mutual aid societies, to school districts and regional food organizations, a network of local and regional agencies and volunteers have come together to support people - as we Vermonters always do.

Brattleboro Development Credit Corporation (BDCC) has been actively addressing COVID's economic impacts. Throughout the first days, weeks, and months of the crisis, every member of BDCC's team pivoted to providing direct business, nonprofit, and municipal support; helped connect over 375 businesses with "PPP" and EIDL federal relief programs; and provided USDA backed low-interest disaster loans to those who could not access other federal relief programs. We continue to convene weekly calls with state and federal officials to ensure the region's needs are heard, and that our regional partners are able to maximize efforts to deliver consistent communications to our businesses, employers, and communities.

We also bring technical assistance to people via webinars, as well as one-one-one support, to assist our small businesses and employers in accessing federal and state recovery programs necessary to their survival. Through our existing USDA-funded, Southern Vermont Economy Project (SVEP) we have added webinars and technical assistance to help local officials navigate everything from how to host a committee meeting on Zoom, to what we ought to be considering as far as municipal budgets and COVID impacts. We will continue to flex our programs and be regionally responsive, as recovery continues in the months and years ahead.

Rebounding from a crisis of this magnitude requires a plan for the long haul combined with short term actions and more involved solutions that will not all be executed overnight. We know businesses and the region need ongoing help now, and we will endeavor to ensure that aid is not provided at their future expense.

Southeastern Vermont Economic Development Strategies (SeVEDS) was born out of other disasters: Tropical Storm Irene and the closure of Vermont Yankee. Today, BDCC's programs are led with research and strategies that have translated those recovery experiences into action. We know that economic impacts occur and must be addressed at a regional scale. Since 2007, SeVEDS (founded as an affiliate of BDCC) has taken a proactive, long-term regional approach to encouraging the development of better wages, retaining and attracting young people, keeping people employed, and fostering a quality jobs base – these are critical to the sustainability of our communities. It is beyond the capacity of any single community to address these key economic indicators at any scale.





SeVEDS' strategy development is guided by the region's Comprehensive Economic Development Strategy (CEDS) and is made possible by funding from our municipal partners. The newest five-year plan, the 2019 Southern Vermont CEDS, is the region's next step towards becoming an Economic Development District to have better access to federal support for economic development efforts. The plan is available on BDCC and SeVEDS' websites. An annual CEDS Project collection and ranking process is an opportunity for your local projects to become part of a regional priority list that makes these efforts more visible to state, federal, and private funders. The development of an addendum to that strategy, acknowledging new challenges and opportunities created by the COVID-19 shutdown, is currently underway.

SeVEDS creates strategies designed to achieve long-term objectives. BDCC attracts resources and builds programs with regional partners. Both help to build a more vibrant resilient economy. Please see the attached programs sheet for more detail, or visit brattleborodevelopment.com

Since 2012 SeVEDS has asked every town we serve to support long-term economic strategies for growth and prosperity through municipal funding. In 2020, sixteen communities funded SeVEDS, representing over 75% of Windham residents. SeVEDS and BDCC leverage municipal support making our innovative planning and programs possible and helping us secure millions of new state and federal funding for the region – sometimes for BDCC programs and projects, but often for programs and projects for other organizations. The capacity that municipal investment has helped to build by investing in SeVEDS makes it possible for this organization to invest in individuals, non-profits, towns, and businesses of all sizes that power the economy.

In support of SeVEDS continued and expanded regional efforts, we are requesting municipal funding for the 2021-2022 fiscal year. We ask every town in the Windham Region to contribute towards regional economic development efforts at the rate of \$3.00 per person, based on town population. We are asking the Town of Wilmington to place SeVEDS in the 2021 general fund budget to appropriate \$5,628 (based on a population of 1,876) to support continued implementation of SeVEDS efforts.

We will follow up to schedule time for our staff to meet with your Selectboard to answer any questions regarding this request, and to provide updates on regional programs and projects.

### 2020 BDCC & SeVEDS Overview

- **Capacity-building for communities.** BDCC's Southern Vermont Economy Project & Community Facilities Assistance Program help towns and non-profits advance local projects. Examples of resources available;
  - Direct assistance for local community facilities projects.
  - Ongoing trainings and webinars on topics such as neighborhood revitalization, the census, broadband.

  - Financial literacy classes, homebuyer trainings, volunteer opportunities and professional development.
- BDCC Paid Internships place college students of all ages with local employers to increase access to career
   opportunities and help employers attract and retain talented people
- The Workforce Center of Excellence is helping to build a regional workforce development system that connects people with opportunities, and employers with people.
  - Convening regional partners in workforce development quarterly and at an annual Employer / Provider Workforce Summit.
  - Running the annual Career Expo for jobseekers and career-changers (going virtual this fall!).
  - Working with employers to fund new workforce training programs.
- Support small businesses and startups with innovative services, lending and technical assistance through;
  - Working each year with employers that provide 25% of the regional jobs base.
  - Trainings and one-on-one technical assistance for entrepreneurs who need help with succession planning, business planning and borrowing, and business "incubation".
  - Financing –connecting people with funders and providing a low-cost USDA-backed "microloan".
- In response to **COVID-19** BDCC & SeVEDS created new webinars and online resources, and provided thousands of personal assists to small businesses, non-profits and towns. We remain committed to ensuring all possible relief and assistance reaches this region so we can plan for a full recovery.
