1. Public Hearing for Zoning Ordinance Changes The public hearing was opened at 6:03 pm

Staloff reviewed the changes that had been made. In the introduction to Article IV, the Village Design Review District should be listed. It should also state that there are 3 overlays, not 2. These are not big changes; they were just omitted previously. Article VIII has a change to window signage, allowing maximum displays potential. The window display size was moved from section 823 K so a business can have 30% of its windows covered by signage rather than the previous 6 sq feet per side. Tuller feels this could be a disadvantage for some, but an advantage for others.

 - Jessica Lee Smith inquired how the auctioneer could be helped. Why does he have to leave so that the lot could be used for a green space, when there is a park across the street.
 Moore commented that the trucks need line of sight coming and going.

 - Under other business, recommend a special meeting next Tuesday at 8 am
- 3. Approve Minutes of March 9, 2021
 - Gannon moved to approve the minutes of March 9, 2021, Rice second; all in favor.
- 4. Zoning Ordinance Approval
 - Gannon moved to approve the proposed changes to zoning articles IV and VIII as presented, with the one addition presented tonight, Rice second; all in favor.
- 5. Public Safety Facility
 - VIS is recommended for Clerk of the Works. The rate is slightly lower, and they have quite a bit of experience with projects of this magnitude. Gannon moved to approve the Public Safety Facility Committee's recommendation for Clerk of the Works, and give the Town Manager authority to execute the contract, Tribuno second; all in favor.
 - Gannon moved to approve a letter of authorization to BreadLoaf to move the project forward pending the AIA contract legal review, Rice second; all in favor.
- 6. Financial Update
 - The general fund revenues are at about 70%. Town Clerk fees are up as are transfer station fees.
 - The general fund expenditures are at 65%, which is on target. Fire Dept looks high, but they have more, such as volunteer stipends that they pay out earlier in the year.

- 7. Bi-Town Marketing Funding
 - Bi-Town Marketing gave an overview on how they are utilizing the Charette plan that was presented previously. Fitzgerald questioned the results we are seeing from the funds already given. Gannon is concerned about the amount of money to re-build the website. Smith commented that a website of a certain platform is inexpensive and simple, and shouldn't cost that much money. Fitzgerald moved to approve funding for Bi-Town Marketing in the amount of \$48,250, contingent on Dover Selectboard approving the same amount, Gannon second; vote 3–1.

Fitzgerald moved to enter into liquor commission at 6:59 pm, Rice second; all in favor.

TERMINATION OF THE MEMORANDUM OF UNDERSTANDING

TO: Member Towns with Loaned WSWMD Recycling Roll-Off Containers:

Brookline, Halifax, Jamaica, Marlboro, Readsboro, Townshend, Wardsboro, and Wilmington

FROM: Bob Spencer, Executive Director

RE: Termination of the Memorandum of Understanding

Background

On November 28, 2017, Windham Solid Waste Management District ("WSWMD") and eight member towns entered into the attached Memorandum of Understanding ("MOU") for WSWMD to loan roll-off recycling containers to each of the eight member towns who agreed to accept them. In accordance with this 2017 MOU, WSWMD loaned, without charge, a total of 26 recycling roll-off containers for use by each of the town's recycling programs at transfer stations, as well as "24-7" sites.

The MOU recognized that the containers would be used by the town's recycling hauler, that WSWMD would provide insurance for the containers, that the towns were individually responsible for maintenance of the containers, and that the MOU would "be effective until terminated."

Terms and Conditions of Termination

At its March 11, 2021 meeting, the District Board of Supervisors voted to terminate the MOUs with the towns, and to transfer ownership of the containers to the towns under the following conditions:

1. The transfer of ownership will occur on June 30,2021, unless a town exercises its option to return the containers at their own expense.

Brattleboro Brookline Dover Dummerston Guilford Halifax Jamaica Marlboro Newfane Readsboro Somerset Stratton Townshend Vernon Wardsboro Westminster Wilmington The containers shall be transferred AS IS, WHERE IS, AND WITH ALL FAULTS. The transfer of the containers is without any warranty or representations as to condition, title, usefulness, or any other warranty under Vermont law or any rights in equity.

- 2. WSWMD shall maintain insurance coverage of the containers through June 30, 2021, at which time any such policy will terminate or expire and shall not be renewed. After June 30, 2021, it will be incumbent on the towns to maintain insurance coverage, as each municipality may determine.
- 3. The Towns have the option to return the containers to WSWMD at their own expense.
- 4. When the useful life of a container has been reached, the town shall be entitled to keep the scrap metal value of the container.
- 5. All ownership shall transfer to the Town via the attached bill of sale, or similar document.

WSWMD Board of Supervisors recommends that the Selectboard of each town review and approve the terms of this memorandum, and sign below to accept the terms for either 1) accepting ownership of the containers, or 2) returning the containers at the town's expense.

1. On behalf of the Town of Wilmington, we, the Selectboard, agree to accept the recycling roll-off containers previously loaned to the Town, and which are currently located with the Town, under the terms and conditions offered in this Termination of the Memorandum of Understanding. We further represent that this acceptance has been duly warned, approved, and authorized by the Selectboard.
