### **By-Laws for The Town of Wilmington Cemeteries**

1. Sale and use of lots in river view shall be subject to and in accordance with the laws of Vermont.
2. Lots Shall be kept free from trees shrubs and vines to keep them well mowed and cared for
3. Price of lots and of single grave shall be decided by the cemetery commissioners.
4. A lot may be bargained to a purchaser if he pays down 1/4 of the price of the lot, with the use of one grave. Balance due on said lot shall be paid within six months of bargain and if not paid within that time the lot or unused part thereof shall revert to the town to be used as the commissioners direct.
5. The commissioners shall hold an annual meeting in March each year and choose a chairman clerk manager and other such officers as needed for work and business of the cemeteries.
  - a. members to be notified of time in place of said meeting by clerk.
  - b. Special meetings may be called at any time by the clerk by giving reasonable notice to each member of the board town of Wilmington within 24 hours.
  - c. Officers so chosen are to hold office one year or until their successors are chosen.

The Sexton shall have care in charge of the cemeteries in cell the lodge pay recedes to the town treasurer and roar orders on the town treasurer to pay bills.

These bylaws may be amended or attitude by a vote of 3/5 of the members of the Commission at any regular called meeting of the commissioners.

# CEMETERY REGULATIONS

TOWN OF WILMINGTON, VERMONT

1. Year-round burials will NOT be permitted between November 1<sup>st</sup> and April 15<sup>th</sup> until weather conditions permits.
2. Grave liners of concrete steel or other suitable material must be used to enclose coffins caskets.
3. Upgrade monuments and headstones will be placed in monument row only.
4. Graves are to be dug by cemetery agents.
5. The owner of a cemetery lot may dispose of same by will to any relative who may survive, or to the town of Wilmington, in trust, for the use and benefit of any person designated in such will V. S. A period T. 185531 a
6. Flower shell only be in move lots the committee shall have the authority to remove all focus regions flags shrubs plant or herbage of any kind which in the judgment of the committee have become unsightly dangerous diseased or detrimental or which do not conform to the regulations outlined. Artificial flowers will be permitted until their appearance becomes unsightly. Artificial flowers must be confined to containers. Both natural and artificial flowers or wreaths shall be removed by law owner or the committee when they lose the original appearance
7. There shall be one full burial per grave two cremation burials per grave or wonderful burial and one cremation burial per grade.
8. No fences shall be erected inside the cemetery by law owners.
9. Glass containers are not allowed. Metal, plastic, or other unbreakable containers are to be used. Proper disposal of such containers shall be enforced containers are not to be left in the cemetery for misplaced items contact the Cemetery Commissioners.
10. the town will provide mowing and clipping engraves will be leveled when necessary.
11. The town will not be liable for morals floral pieces plantings benches or decorations damaged by the element's vandals' thieves or by other causes beyond its control.
12. No lot shall be used for any purpose than the burial of the human dead.
13. Person visiting the cemetery or attending Funeral services are prohibited from picking flowers wild or cultivated breaking or injuring any trees shrubs or plants or from riding upon defacing or injuring any memorial, fence, or other structures within the grounds.
14. Ornaments and similar artifacts are permitted on or near the headstone, an if so, placed on the lot to be replaced monthly the town reserves the right to remove the same.
15. No monument or marker shall be removed from the cemetery except by the town, unless the written order of the lot owner is presented at the town clerk's office.
