Short term rentals

John sent a link for the Planning Commissioners to reference. There are 330+ short term active rentals in town. The State has been discussing Short Term Rental registry but it was vetoed.

Mike noted there often was no on-site manager. He has had difficulty reaching the actual owner of the property if needed. John said Killington is using a third party which isn't great set up. It has a permitting process.

The State is going to "take charge" of inspection of short term rentals.

Can the Planning Commission regulate it in any way?

Mike feels these rentals are killing affordable housing. He thinks owners should live on site or have an on-site manager. They often impact noise, parking and septic.

Meg wondered if the Select Board has any interest in taking this up. Mike thinks they are waiting for the State to take this up.

John is willing to talk to Tom Fitzgerald, Select Board chair, about possible interest.

Michele goes along with what we've been doing It is helpful to know numbers and how it impacts emergency, roads and infrastructure.
