Articles 5,7, 8, 10 were discussed. These address outdoor dining, solar arrays, public art, electric vehicle charging stations, signage, and definitions. John went through the Zoning Document and noted the proposed changes.

Meg asked about the footnote in the document and wondered if it should be removed if changes are approved because it will no longer be necessary. [It will not be necessary.]

This is a formatting change, no longer a By-law change.

There was further discussion on specific reasoning for the proposed changes.

Meg thinks we had agreed to strike the last sentence in 732 I. This change had been approved at a prior meeting. It was agreed this was an error when adding track changes and should be stricken.

Mike Eldred asked why the changes to the sign ordinance were made. [Many signs presently used are in violation of the ordinance as it is presently written. The proposed change is in line with the present signage use.]

He also questioned the reasons for changes to public dining. [These changes were originally made during Covid. It was agreed that continuing these permits is beneficial to the Town and the businesses. Scott noted the state is also pushing increased outdoor dining.]

Chris Mays asked about the reasoning behind Public Art additions. [In the present zoning document there is no definition of Public Art, but there needs to be one. Public Art is encouraged.[

John closed the Hearing at 5:23 PM.

Michele made a motion to reopen the meeting at 5:25 PM. Angela seconded.
