Wilmington Selectboard Meeting Minutes June 20, 2023

Meeting called to order at 6:00 pm

- 1. Visitors, Public Comments, Possible Changes to the Agenda
 - Other business; set a special meeting for a liquor license for HMC
- 2. Approve Minutes of May 16 and 25, 2023
 - Tribuno moved to approve the minutes May 16, 2023, Fisher second; all in favor.
 - Fitzgerald moved to approve the minutes of May 25, 2023, Fisher second; 3-0, Tribuno abstained.

3. Action Items

- Fitzgerald moved to approve the Town Hall Relocation Committee Resolution, to include John Gannon, Sarah Fisher, Therese Lounsbury, Christine Richter, and Jessica Roberts, Gannon second; all in favor.
- Fitzgerald moved to approve the private road name, Dandelion Way, off of Route 9 W, Fisher second; all in favor.
- Fitzgerald moved to accept, with deep regret, the resignation of Chuck Clerici as Energy Coordinator, Tribuno second; all in favor.
- Fitzgerald moved to approve the annual Certificate of Compliance for Town Roads & Bridge Standard for Vtrans, Fisher second; all in favor.

4. Bi-Town Committee Charge

- Bi-town updated their charge, meeting every other month. The Mullen report and FEMA LTR plan were removed, and some sub-committees were adjusted. Gannon moved to approve the updated Bi-Town Committee charge, Fisher second; all in favor.

5. Tennis Courts

- We crack seal the courts every year, but the cracks just get worse each year. The courts were built in the 70's and need to be replaced. If we could get a good estimate, we could dig the courts up, have the sewer inspected that lays underneath, and have them rebuilt, using 1% LOT, grant funds, and budget money. Yankura commented that if everyone works together, something good can come of it, even possibly re-locating them. Lounsbury thinks either the Lions Club or Rotary adopted them to care for them years back.

Fitzgerald moved to enter into Water Commission at 6:24 pm

6. Water Commission

The budget increased 14.89% due to staffing changes. Richter is looking to move billing to 3 times a year, and then combining water and sewer bills. Gannon moved to approve the budget as amended and set the usage rate for FY 24 per the document received, Fisher second; all in favor.

- Water and Highway will share an employee. He will be focusing on building maintenance, groundskeeping, snow removal and other jobs for highway. A part-time employee has been working at and learning how to run the transfer station. The position will be under 24-hours per week and will be strictly for transfer station.
- Lounsbury made the comment that the transition of three times a year and combining bills may affect those on fixed incomes.

- I Love Art Space is looking for 9-10 screens for displaying art, which would be used for shows, and possibly outdoor events. Fitzgerald moved to approve a 1% request from I Love Artspace in the amount of \$7300, Tribuno second; all in favor.

8. Liquor Licenses

- Tribuno moved to approve a Special Event permit for Cold Spring Spirits, LLC dba Mad River Distillers on July 25, 2023 at Haystack Golf Course from 12-6 pm, Fisher second; all in favor.

- Perry Property on East Dover Rd; received grant \$181,578.94 for the buy-out.

- DVSJ are interested in using a piece of land to help cross Higley Hill Rd. We will be asking DVSJ for a signed letter from all abutters agreeing to their plan.
