Meeting called to order at 6:01 pm

1. Visitors, Public Comments, Possible Changes to the Agenda

- Ryck Morales of FEMA informing the town that they are still here and there are still programs available.
- John Redd wanted to comment on what he felt was abuse of process at the Planning Commission meeting. He is asked for the resignation of the Chair.
- James Walker is asking for clarification on next steps for STR's.

2. Approve Minutes of October 17 and 24, 2023

- Tribuno moved to approve the minutes of October 17, 2023, Rice second; 4–0, Gannon abstained.
- Gannon moved to approve the minutes of October 24, 2023, Fisher second; 4-0, Fitzgerald abstained.

3. Social Services

 SASH is requesting an additional \$5000. They are seeing more needs and overseeing more programs. Distributing 46 boxes of food a month; 20 in Wilmington. Dover is the only other town contributing. Dover currently contributes \$20,000.

4. Action Items

- Fisher moved to approve the amended municipal resolution for the Arts & Cultural Regional Plan, Gannon second; all in favor.
- Gannon moved to approve the amended zoning fee schedule listing the .10/ft change, Tribuno second; all in favor.
- Fisher moved to approve the FY24 Grants-in-Aid Supportive Work Request, Rice second; all in favor.
- Gannon moved to appoint Bob Bois as the Energy Coordinator for the remainder of a 1-year term, Fisher second; all in favor.
- Gannon moved to approve the Wilmington Energy Committee Resolution, Tribuno second; all in favor.

5. Police Dept Drone

- A drone will help to keep officers and emergency personnel from exposure/unsafe conditions like being on a frozen lake searching for a lost person. They have the FAA license to operate the drone. Search and rescue will be a primary use, and collision mapping as a secondary. Gannon moved to approve the purchase of a drone from Skydio in the amount of \$16,144.09, Rice second; all in favor.

6. Highway Road Re-Classification

- Highway is applying to the state for re-classification of Shearer Hill Rd. This will increase the amount of state aid the town receives; paving may be all the way through to the town line, and the state will paint the yellow lines. The Selectboard supports the possible re-classification of Shearer Hill Rd from a Class 3 to a Class 2 road.

7. Town Meeting Survey

- The Selectboard reviewed the results of the survey regarding town meeting. There were 192 respondents. PowerPoint available at https://wilmingtonvermont.us/committees-minutes/selectboard/. Streeter stated that maybe mailing ballots is an option, since the highest turnout year was during COVID. Hybrid or virtual meetings is a question for the legislature. Steel commented that some people don't attend if the skiing is good. Her wish is for the town to make a 3-year commitment to try different things, to try and increase participation.

8. 1% Local Option Tax Fund

Town employees have been looking at different holiday lighting options at Town Hall and are leaning toward snowflakes. Lorimer would like the greenery that used to be put on the building to be considered. Wilmington Works is running a program to try and get business lighting the same color running through the downtown. Gannon moved to approve \$8000 for holiday lights on Town Hall from the 1% Fund, Rice second; all in favor.

Fitzgerald moved to enter into Liquor Commission at 6:45 pm, Rice second; all in favor.

9. Liquor Commission

- Tribuno moved to approve a 1st and 3rd Class renewal for Roberts Roadhouse, Fisher second; all in favor.

Out of Liquor Commission at 6:46 pm.

10. Other Business/Correspondence

- We have a request to support tomorrow's leaders; a request to sponsor a student's trip to the Galapagos Islands.

Dear Mrs. DeFrancesco,

I am sending this for submission to the Town of Wilmington Selectboard or funding committee. Senior Solutions requests \$1,000.00 from the Town of Wilmington to be appropriated at the 2024 Town Meeting.

Enclosed are reports showing the services we provided to residents of the Town of Wilmington.

Please continue to appoint an interested representative to our Advisory Council every year. This helps us connect with those who will benefit from our services and identify local needs.

Speaking of local needs, older Vermonters in Southeastern Vermont have faced many unexpected challenges over the past year: higher costs for food, heat, transportation, and housing; serious health issues; and a catastrophic drop in the number of direct care workers. Coupled with the recent severe weather events bringing devastating flooding, it's becoming increasingly difficult for them to age in the places they choose, without timely, steady support.

To help our neighbors overcome these obstacles, Senior Solutions works diligently to strengthen the comprehensive system that serves them and their caregivers. We continue to collaborate closely with local aging-in-place, Cares and Mutual Aid groups to help assure needs are being met in local communities. Within three days of the recent flooding, our staff had restored all meal deliveries and began providing direct support to those affected by the flooding—whether they needed assistance with benefits or a specific intervention such as a microwave or help with cleanup.

Beginning in 2021, our nutrition program staff launched several 100% Campaigns to raise awareness of food benefits, fuel assistance, and other resources. We call them 100% Campaigns because we mailed information to 100% of the residents in areas that we know have a high need for these programs but low enrollment in them. Every resident in twenty-two (22) towns across southeastern Vermont, including every resident in your town, received information on these programs and guidance on where to turn for help. The response to these campaigns has been outstanding and has allowed our staff to direct critical assistance to those in greatest need.

We also seek to reduce the burdens of isolation and loneliness. We have a volunteer corps that provides friendly visits to isolated older Vermonters. Our Foxy Fund is helping to alleviate isolation and loneliness by providing hundreds of pounds of pet food each month and helping to cover veterinary costs for Meals on Wheels recipients.

Supporting caregivers is also an important part of our work. We partner with local and statewide organizations to promote and operate programs that provide financial resources, rest, and relief for those taking care of dementia patients and older adults with serious health conditions. We encourage counseling for caregivers and host memory cafes where caregivers and their loved ones can relax and socialize in a safe and supportive setting.

As we all know, the population of older adults in Vermont is increasing, as are the costs of goods and services across the board. For Senior Solutions, this means that both the cost of each service and the total number of people requesting each service is going up. Although we continually seek funding from new sources, financial support from the towns we serve is critical to enabling us to do more for the older Vermonters we serve.

On behalf of all Grace Cottage patients, including many who are residents of Wilmington, we hope that you will please add the following warning in your 2023 Annual Report, for consideration at Town Meeting in 2024:

"To see if the Town of Wilmington will vote to raise \$2,500 by taxation for Grace Cottage Family Health & Hospital."

Grace Cottage Family Health & Hospital is a five-building healthcare facility offering a range of health-related services. Grace Cottage Hospital, a non-profit 501(c)3 independent organization, is comprised of a 19-bed inpatient hospital for acute and rehabilitative care; a 24-hour Emergency Department; a hospice care suite; a laboratory; and diagnostic imaging including CT scanner, X-ray, ultrasound, and bone density. With 15 physicians, nurse practitioners, and physician assistants, Grace Cottage Family Health Clinic offers physicals and wellness visits, chronic disease management, pediatrics, geriatrics, and mental health services. Grace Cottage's Community Health Team offers free services to area residents, including nutrition and lifestyle education, diabetes education, and help with applying for health insurance and connecting to community resources for food, fuel, and housing assistance. Grace Cottage's Rehabilitation Department offers exceptional care for hospital patients and outpatients, with 15 physical and occupational therapists on staff. Expanded services include lymphedema therapy, custom orthotics, women's health, and pelvic health therapy. Messenger Valley Pharmacy, a full retail pharmacy open to the public and owned by Grace Cottage, fills prescriptions from any provider, including veterinarians.

Services provided by Grace Cottage Family Health & Hospital during FY23 (Oct. 1, 2022-Sept. 30, 2023) included the following:

30,085: Patient visits to Grace Cottage Family Health Clinic

3,547: Patient days in Grace Cottage Hospital

4,077: Emergency Department visits

9,701: Outpatient Rehabilitation (physical and occupational therapy) visits

1,631: Diagnostic Imaging visits (CT Scan, X-ray, ultrasound, bone density)

1,490: Community Health Team visits

542: Covid-19 tests

Number of patients who are Wilmington residents: 177

All of our services are available for residents, second homeowners, and visitors to Wilmington. Grace Cottage Family Health & Hospital is a non-profit 501(c)3 corporation which depends on the generosity of supporters to keep it going, especially in view of cutbacks in Medicare/Medicaid and insurance reimbursements. Each year, Grace Cottage provides a substantial amount of free care for those in need; in FY2023, that amount was approximately \$900,000. Fundraising helps us fill this gap, along with town appropriations.



- 3. Fifty-five gallon drums may be brought to the transfer station and deposited in appropriate place if **both** ends of the drum are cut out.
- 4. No one may go through the scrap metal pile.
- 5. **Payment:** Payment for disposal of solid waste at the transfer station may be by cash or check made out to Town of Wilmington.
- * Examples of Household Hazardous Wastes That Should <u>NOT</u> be brought To the Transfer Station: (save them for the free hazardous waste collection!)

FLAMMABLE LIQUIDS: turpentine, furniture strippers, spot removers, wood preservatives

- 1. TERMS TO GOVERN. The terms and conditions set forth herein shall constitute the sole terms and conditions of sale for this quotation (the "Quote") and any orders placed thereunder. - 2. TITLE/RISK OF LOSS. Title and risk of loss shall pass to Buyer at the time the goods are delivered to or picked up by Buyer.
- 3. PAYMENT AND CREDIT TERMS. Failure of the Buyer to pay on the due date for products shipped shall give Seller the right, but not the obligation, to suspend further shipment, without notice to the Buyer, until all previous shipments are paid, or to terminate this agreement and seek all available remedies from Buyer. Interest at the maximum rate permitted by law will accrue on all invoices unpaid as of the net due date. All payments by Buyer shall be final 180 days after shipment of the goods and Buyer shall have no right to audit payments or deduct future payments after such date. - 5. EXCLUSIVE REMEDY. If upon delivery to Buyer the goods appear not to meet the above warranty, Buyer shall immediately notify Seller who shall have a right to inspect them. Buyer shall not return, repair or dispose of any goods that fail to meet the above warranty without Seller's written consent. In the event Seller breaches the above warranty, Buyer's sole and exclusive remedy and Seller's sole and exclusive liability shall be limited to, at Seller's option, replacement of non-conforming goods with conforming goods or return of the purchase price.
- 6. FORCE MAJEURE. Seller shall be excused for failure to deliver or delay occasioned by conditions beyond Seller's reasonable control, including, but not limited to, Acts of God, fire flood, windstorm, acts of governmental authorities, strikes shortage of raw materials, breakdown, shortage or non-availability of transportation facilities or equipment or any similar event not within Seller's control. In addition, if Seller is unable, for any reason, to supply the goods from its plant closest to Buyer's facility, then Seller may, but is not required to, supply the goods from another plant, to the extent it is available, subject to Buyer's payment of all increased freight costs.
- 8. DELIVERY. Buyer shall furnish complete shipping instructions in sufficient time to enable Seller to perform its obligations hereunder. Seller shall not be obligated to make shipment in absence thereof. If more than one delivery is called for, each delivery is to be considered a separate contract for purposes of furnishing complete shipping instructions by Buyer. - 10. TAXES.
