- 2. Approve Minutes of November 7, 2023
 - Gannon moved to approve the minutes of November 7, 2023, Rice second; all in favor.

3. Social Services

- Senior Solutions; responded to 53 calls from Wilmington seniors, have time at the OFH twice a month, provide 20% match to MOOver for trips made for residents; request \$1,000.
- Grace Cottage; 31,000 patient visits per year at primary care. Emergency room volume is increasing. The are approved to build a physician clinic. 177 residents from Wilmington use Grace Cottage for primary care; request \$2,500.
- Wings; re-applying for grant this year which requires a 50% match. Other towns contribute to this program. TVES summer program had over 120 kids registered each week; request \$11,000.
- VNH; no show
- SafePlace; no show

4. 1% Local Option Tax Fund Request

Bi-Town 2024 Digital Marketing Campaign; the click-rate/search doubled in the fall. Tik-Tok and Instagram reels were utilized. Over 4-million impressions and 9500 clicks on the website, with over 23-million impressions for the year and 54,949 clicks on the website. Offered a partial grant in the amount of \$38,400 from the Vermont GROW Program. Would like to create a new position of content creator. A new campaign will be needed; photos, videos, media. The request is about \$50,000 increase from last year. Gannon moved to approve a funding request for the 2024 Digital Marketing Campaign by Bi-Town Marketing Committee in the amount of \$107,548, Fisher second; all in favor.

5. Action Items

- Fitzgerald move to re-appoint Jessica Roberts to the Town Hall Re-Location Committee, Tribuno second; all in favor.
- Tribuno moved to accept, with regret, the resignation of Karen Molina from the Recreation Commission, Rice second; all in favor.
- Planning Commission Chair Lebron requested that the Selectboard send a section back to the Planning Commission, since he isn't comfortable with the last-minute change. Gannon commented that if people have issues with the outcome from the Planning Commission, they

can speak to it at the Selectboard hearing. Fitzgerald moved to receive the proposed Zoning Ordinance and report, Fisher second; all in favor. Meetings will be December 12th and 19th, with a hearing date on January 9, 2024; all at 6 pm.

- Proposal to increase costs to the nearest dollar; increase permits by \$5; seniors change to \$3 per bag. Gannon moved to approve the updated Transfer Station Fee Schedule, effective January 1, 2024, Rice second; all in favor.
- Replacing a 2018 RAM with a Ford F6 and can only get the truck body from one place. Truck prices have gone up significantly. Gannon moved to approve the purchase of a highway truck body from Viking-Cives for \$66,000 and a truck from Autosaver for \$45,351 for a total cost of \$111,951, Tribuno second; all in favor.
- Road sale price is the same as last year, with a different vendor. Gannon moved to accept the road salt quote from Cargill in the amount of \$86/ton, Rice second; all in favor.

Re: School Resource Officer

It is my recommendation, consistent with our recent discussion, that we approach both the Windham Southwest Supervisory Union (Twin Valley Elementary and Middle/High School) and the Town of Wilmington to seek funding and approval to pursue a grant to implement a School Resource Officer (SRO) program. As you are aware, the Wilmington Police Department (WPD) has been responding to and assisting both schools as much as our resources allow. An SRO can assist the schools with threat assessments, security, coordination of police investigations, mentorship/informal counselor, as an public safety educator, and with emergency management planning. I believe that this partnership will help provide a more comprehensive approach to school safety concerns and provide better communication for incidents that often impact both the school community and greater community, to include households and neighborhoods.

The Department of Justice offers a COPS Hiring Program grant. This grant (if awarded) currently provides up to \$125,000 over 3-years (\$41,666.66 per year) towards an officer's salary and benefits. Currently it costs approximately \$120,000 per year for the salary and benefits of an officer at Wilmington Police Department. I will plan on applying for the next COPS grant cycle, which will open in May 2024 and will likely close sometime in August 2024. There is no guarantee that this grant will be awarded. Therefore, I recommend that the Windham Southwest Supervisory Union and the Town of Wilmington, Police Department explore cost sharing and budget for the next fiscal year, as follows:

Officer Salary and Benefits: \$120,000

- Supervisory Share: \$96,000 (80%)
- Wilmington Police Dept. Share: \$24,000 (20%)

During the summer months when the schools are closed and teachers are released, the School Resource Officer would work the majority of those hours reflected in the 20% cost share as a regular officer for WPD or other programming. The SRO would follow the teachers' schedule throughout the school year.

In the event that the grant is awarded then both the supervisory share and the town share for the three grant years would be reduced by the applicable percentage of the grant. So, if the grant is awarded then the supervisory share would be approximately \$62,666.67 and the town's share would be \$15,666.67.

In order to ensure the success of the SRO program and maintain its effectiveness in developing successful working relationships and collaboration within the schools, I recommend that a seven-year agreement be established with an appropriate Memorandum of Understanding that will outline specific responsibilities for both parties. In addition, it is important that we plan to join the National Association of School Resource Officers and commit to both basic and advanced SRO courses designed to prepare SROs, school administrators and/or education professionals to effectively fulfill their roles in a school setting www.nasro.org.

It would be my pleasure to accompany you to both the Supervisory Board and Selectboard meetings to present this proposal.

RECOMMENDATIONS FOR TOWN MEETING 2024

- Town Reports get mailed.
- Time/Day Change? Evening meeting makes voting day too long the day starts at 6am to open polls for 7am, and we do have voters at that time (could count to see how many and whether we could open later); by law the polls close at 7pm and BCA has work to do to close out the tabulator and count write-ins, and Town Clerk has transport back to the vault, completing election night results for the Secretary of State's office, and media outlets to contact. Evening hours would also discourage our Seniors. Weekends disenfranchise the residents that work in the hospitality industry, and while it may seem helpful to keep the schools open that means those residents don't get to attend. There is no legislation providing for virtual attendees. My recommendation is to remain at 10am on the traditional first Tuesday of March.
- More than one Informational Meeting, choosing different nights of the week. Any of the ten
 days prior to the election can be used for informational meetings. We could try to do one backto-back with the school they traditionally do the 4th Tuesday in February.
- Make use of social media outlets, the town e-newsletter, and school newsletters. An ad could be placed in three newspapers for a listing of the seats that have terms that are ending.
- Encourage employers to allow staff to go and not lose pay.
- I will ask to borrow the tax time sign to announce Town Meeting Day & Voting. The voting signs that are placed at either end of Beaver Street a minimum of four days before the election can be placed a week before and monitored daily for snow removal and visibility.
- Let's be honest voting is a fundamental right which is protected under federal and state law; 17 VSA 2666 says that the official election materials cannot have "improper influence", and 17 VSA 2017, which talks about bribery and undue influence on voters while that primarily addresses the physical process of voting a ballot, there is no need to blur the lines of the polling place's integrity, or to draw in unregistered voters. We already have an entity providing lunch in the building, and morning coffee & snacks. Residents will have to make their own daycare arrangements there isn't a space in the OSEC building to accommodate additional children. We cannot combine it with the school meeting the unified union means it is two towns voting at the same time you can't vote that from the floor in two separate locations.

- Things of note for March 5th: Presidential Primary voters will need to declare which ballot they would like to take to the voting booth; a Presidential Primary tends to increase the voter turnout; the Whitingham BCA will transport the school ballots from Jacksonville to Wilmington at the close of the polls on March 5th.
- Things of note for November election Since once again the SoS will be mailing the November election ballots, I am trying to decide on the best method to get people to review their mailing address with the Town Clerk's Office especially students that often change their residential location.
