IN ATTENDANCE: A quorum was achieved with 8 members present: John Lebron, Tony Tribuno, John Gannon (via Zoom), Meg Streeter, Bonnie Lorimer, Therese Lounsbury, Tom Fitzgerald, Sarah Fisher.

- 1. CALLED TO ORDER** – Chair John Gannon called the meeting to order at 8:30am.
- 2. MINUTES APPROVAL** – Motion to approve the minutes of February 21, 2024, as written. Motion made by John Lebron, seconded by Bonnie Lorimer. Motion carried.
- 3. CHALLENGES TO THE VOTER ROLL** – Motion to approve the list of voters to challenge based on USPS mail return and the Electronic Registration Information Center (ERIC). Bonnie suggested two individuals may have died – the Town Clerk will research. In the event of a death, the Town Clerk has the authority to remove the voter from registered voters in the town. Motion made by Meg Streeter, seconded by Sarah Fisher. Motion carried.
- 4. SHARE CANDIDATE DOCUMENTS FOR JUSTICES OF THE PEACE** – Therese distributed the Consent of Candidate and Petition forms needed to be on the ballot in November. Both forms need to be returned together to the Town Clerk’s Office by Friday, August 16, 2024. Your current term ends February 1, 2025.
- 5. NEXT ELECTIONS** – State Primary is August 13th, and General Election on November 5th. Please place these dates on your calendars! JOPs can still work the polls, even though you are on the ballot.
