# Review and Discussion of draft language relating to limits on number of guest rooms for short term rentals:

Discussed the timeline of possibly adding this to the recommended Bylaw changes to the Selectboard hearing at their scheduled Nov 4<sup>th</sup> meeting. Following discussion, and in the best interest of community the PC would like further review and to hold a Planning Commission public hearing on this topic prior to sending recommendations to Select Board.

#### **Shorelands:**

- Wilmington current bylaws do not include specific language from the states Shoreland Protection Act (10 V.S.A. Chapter 49A). PC discussed providing the Select Board with new language to consider for shorelands in time for their zoning/bylaw hearing on Nov 4<sup>th</sup>. As this is state regulated by ANR (Agency of Natural Resources) and definitions and language would not be changed, the PC sees this as a practical to add to upcoming Select Board hearing.
- Lake Raponda falls under the jurisdiction of the Shoreland Protection Act (body of waters that exceed 10 acres).

Erik made a motion to approve adding state regulated Shoreland definitions and regulations to Article X – Definitions and Article VII Section 730: Conditional Use-Specific Standards. Cheryl second; all in favor.
