2026 Annual Town Meeting Held in the Gym at the Old School Enrichment Center (OSEC)  
Minutes  
March 3, 2026 – 10:00am

Town Moderator Robert Fisher called the meeting to order at 10:00am with approximately 82 voters in attendance. He then recognized Scout Daltyn Hurley from Scout Troop #461 to post the colors and lead the Pledge of Allegiance. This was followed by a moment of silence for those friends and neighbors who are no longer with us.

The meeting was then suspended for updates from the following legislators: Senator Seth Bongartz, Senator Rob Plunkett, and Representative Emily Carris-Duncan.

Representative Emily Carris-Duncan started with a presentation for Buddy Hayford. Both Senators and Representatives Emily Carris-Duncan and Laura Sibilia sponsored a Resolution in honor of Leland “Buddy” Hayford’s 500<sup>th</sup> career win, Vermont Coach of the Year, and the longest serving Athletic Director in Vermont. His list of accomplishments was read, and Buddy was presented with a certificate.

Senator Seth Bongartz (10:06am), Chair of the Senate Education Committee, gave his update: he shared that the current education funding system is byzantine; double digit school spending; have to do something to control the rate of increase in spending; need foundational formula; an urban/rural divide is forming – trying to bring many voices together. (88 voters now in attendance) Voter Bill Adams commented that it needs to be on individuals and not on property. Senator Bongartz said he was not disagreeing, but it was created that way because the property base is more stable. He feels the legislature needs to find the money to offset the spending because the current buy down is not sustainable – need that foundational formula and structure underneath. Voter Barker Willard, III, asked if they could contain the spending in the districts and not burden other areas; perhaps we could attract more people to the area; is there a possibility of changing tax codes? Stop with the salt on the road – can reduce spending right there – State trucks throwing salt when not needed then plowing it off and rusting vehicles in the process. Senator Bongartz replied that there were no committees yet concerning tax codes; the Brigham decision makes it clear that we must have comparable opportunities for all. Voter Cliff Duncan agreed that they need to get a hold of the education spending as well as the formula and stated that the County Sheriff’s initiative to place property tax for a countywide policing system if allowed, will end up affecting Wilmington. Senator Bongartz replied that it is all voluntary participation, will not affect Wilmington, it will help communities without police forces, and those communities are already paying the Sheriff’s Department for coverage. Voter Ann Manwaring commented that the town already pays property tax for the court systems and sheriff and was sorry to hear that Seth had voted for it. In fifty odd years, she has never seen a side judge come and talk to us about the taxes they are raising out of our communities.

Senator Rob Plunkett (10:26am), instructed the room on how a bill becomes a law. (92 voters now in attendance) He then shared that 399 Bills have been introduced in the House with only 25 having passed the House; 171 Bills were introduced in the Senate with only 11 passing the Senate; 3 Bills have passed both House & Senate (one was a holdover from last year) but nothing has been signed by the Governor. A lot of the work will happen next week. Senator Plunkett sits on the Institutions Committee. The Windham Pilot Project (the county-wide sheriff coverage) passed – does not affect Wilmington, only those that join. Senator Plunkett wants to hear from us with concerns on this, it does sunset in 5 years. In Agriculture, working on a Farm & Forestry security fund – recovery funds, and a giant miscellaneous Agriculture Bill that will look at municipal regulations of agriculture, tax exemptions, seed law, pesticide application, hemp regulations, and might even look at Current Use. Some of these may not be part of it because it has not been introduced yet. (109 voters now in attendance) Voter Doug Wheeler expressed concern about budget, and whether the State could plan for a level budget and not go over. Social Services spending is getting ahead of regular budget items. Senator Plunkett responded that they always stick to a budget, there is no deficit spending, and they are operating with much less

federal funding. It is a very lean budget year. (125 voters now in attendance) Voter Barker Willard, III, asked for more depth on Current Use. Senator Plunkett responded that it is in the proposal phase, and they are looking at changing the presumption that a farm building would be for agricultural use and not needing pre-approval. Voter Willard replied that his concern is about the properties being placed in Current Use and then are posted to limit access. Senator Plunkett replied that he has heard that concern from others.

Representative Emily Carris-Duncan sits on the Commerce & Economic Development Committee, and part of their conversations have been about career technical education. It was shared that Twin Valley Elementary School achieved a 12 on their state level assessment which shows that they are exceeding expectations. This news met with applause. Representative Carris-Duncan is also on the County Governance Task Force, which is looking at indirect costs that increase spending, things like health insurance costs, out-patient drug prescriptions, and housing concerns. There is also a concern about the opacity of property tax directives. Voter Kenneth Sklaw asked what was happening in the legislature to help with health care services, and about a luxury tax. Have they looked at what other states are doing? Can we partner with other states or look at things regionally? Representative Carris-Duncan stated that Vermont just won a federal grant to help with rural health services, looking at a contract for an Rx card that will help drive down costs, and there is a conversation regarding a luxury tax. Emily wanted to respond to the earlier salting comment – standards of salting, sanding, etc., are being reviewed as the transportation fund is in trouble. Voter Barker Willard, III, asked how the lowering of prescription costs will help when there is no competition amongst health insurance providers when there are only two in the state. Representative Carris-Duncan responded that that was outside her area of expertise but felt that attracting more people to the state by solving housing relief and increasing the pool of people for health care costs. It is a cyclical problem.

Moderator Robert Fisher recognized Chief Matthew Murano for one last presentation (10:50am). The Wilmington Police Department Community Service Award was given to Kathy Larsen for her above and beyond assistance with helping a community member.

The moderator announced (10:54am) that lunch will be offered in the Music Room by the Spanish Class, that Roberts Rules of Order will be followed, that amendments must be germane, to step up to the microphone and state your name, that a paper ballot can be asked for with the support of 6 other voters, that a 2/3 vote is needed to end discussion and non-registered voters wishing to speak will need the acceptance of the group. He then asked if the floor would allow the non-registered voters that are town employees to speak. The floor voted to allow.

The opening statement of the 2026 Warning for the Wilmington Annual Town Meeting was read by the moderator: The legal voters of the Town of Wilmington are hereby notified and warned to meet at the Old School Community Center (OSEC) in said Wilmington, Vermont, at 10 A.M. on Tuesday, March 3, 2026, to consider and act on the following articles not involving voting by Australian Ballot. (Voting for all Australian Ballot articles will be held at the OSEC in said Wilmington, Vermont, on March 3, 2026, from 7:00 am to 7:00 pm.) With unanimous consent, the floor chose to forego the reading of the entire warning. The Selectboard and Town employees seated at the front of the room introduced themselves. In attendance were Selectboard Members Tony Tribuno, Charlie Foster, Vince Rice, Tom Fitzgerald, John Lebron; Town Clerk Therese Lounsbury; Town Manager Scott Tucker; Finance Officer Christine Richter; Police Chief Matt Murano; Fire Chief Scott Moore; Highway Supervisor Marshall Dix.

**Article 1:** To elect all Town and Town School District Officers required by law AND to authorize the Town to obtain a general obligation bond, for the purpose of building a solar array on the Public Safety Facility rooftop (Australian Ballot - Polls open 7:00 A.M. until 7:00 P.M.)

Discussion: the Energy Committee proposed this initiative to the Selectboard and it was approved in a 3 to 2 vote; what will it add to the tax rate; costs will be shared; \$38,000 per year (not even a half penny to the tax rate); should have been two articles; will this interfere with radio system; solar and radio antennas can cause

interference; can it go elsewhere; do not vote for this; savings to power bills, panels on flat roofs are common, reviewing radio interference, estimates based on summer exposure, replaces \$30,000 annually; is the electricity rate high because it is zoned commercial; large building and heat pumps cause the electrical bill; 7-year return on investment, life of project is 25 years, goal is to save the taxpayers money; is engineer cost figured here and any radio interference change, over \$8 million in bonds out there now, come from other capital funds; low profile ballasted unit – does not permeate the roofing, IRS direct payback program will require a consultant to help recoup the incentive, consultant cost of \$12,000; radio interference needs to be addressed as lives are on the line, not opposed to solar; people already voting on this but there is a lot of opposing information that others are not hearing; bond vote must be by Australian Ballot by statute, had two informational meetings and postings in the newspaper; Fire Department has radio system separate from police, dispatched through Keene, New Hampshire, which is going through total system upgrade, not a flat roof – pitches storm runoff to the center; how to be asked to vote on this when don't have all the answers, fan of solar and saving money, but missing some of the bottom line mechanics; thanks to efforts of Energy Committee; what if approved are we committed – if defeated can there still be a discussion; it will be up to the Selectboard to move forward; it will be up to the vendor to convince us that the radio interference can be solved.

Debate (including but not limited to): what did Selectboard eliminate and not include; health insurance change, rehabbing trucks to save money, don't have potential employees waiting in the wings anymore; have had major changes listed in previous reports – that was helpful; why some salaries up by larger percentage than others; value of employees and changes in work load and duties, annual wage review, meet or exceed median rate, cost of living, highly competitive employment market; trends last two years – line 1 on page 18, grown \$1.1 million in two years – not sustainable, a lot flat lines thanked for but is that sustainable, line 170 should be called Health Insurance, most expensive health care in the country, not attracting people; page 15 – 1% Local Option Tax – page 16 – ADU & Route 100 Appraisal/Study; ADU – incentive program from Economic Development, Route 100 was money set aside to do appraisals on private property that have flooding consequences to town along the North Branch of the Deerfield River; Social Services have added \$123,000 to this budget; if ask for increase it is a separate article otherwise falls within the budget; reports from Social Services in the Town Report; does not show how the money was spent; page 60 – VMP – Veterans Memorial Park – all donations; page 29 – Revolving Loan – loans given to startup businesses that are repaid with interest; to get the total budget you would add up all the articles on the warning.

Thanks to Marshall and his team for their work, set up capital fund for paving and the amendment removes the paving of Country Club Road and Green Road – both dead end roads, paved the dirt road and now have to salt the roads; some roads need repair, second homeowners pay a lot into our community and only benefit from roads and fire; highway department has to be able to do necessary road work; we're losing dirt off the roads, did dig down and rebuild those roads, pavement more cost efficient, many roads are 10 to 11 years before re-paved; new bridge on Green Road had to raise the road level, only added 100 feet of pavement, mud gets so bad on Country Club Road that cars have trouble stopping at the bottom plus it washes out onto the State road; Paving Grant labelled as expense – this is a matching grant so amount that needs to be expended before getting money back; spent on paving East Dover Road, re-surfacing on page 24, line 289; plan for re-surfacing: Shearer Hill Road, Town Farm Road, West Road, Haystack Road – has base coat; could a paving report in the book be considered.



## **Vermont Municipal Clerks' and Treasurers' Association (VMCTA) Statement about Threatening of Election Officials**

The VMCTA strongly condemns threatening, harassing, bribing, or interfering with election officials, either while performing their duties, or outside of their work hours. We also condemn threatening, harassing, or interfering with the lives of their family members, pets, or close friends. Election officials perform their work under oath to uphold the laws of their state and of the United States Constitution. Injurious acts toward election officials will not change the outcome of a vote. Anyone with a complaint about the acts of an election official should follow the procedures of law, as required by 42 U.S.C. § 15512(a), and 17 V.S.A. § 2458.



### **Statement of the Vermont Clerks and Treasurers' Association**

The Vermont Clerks and Treasurers' Association reaffirms its commitment to faithfully administer and enforce Vermont election law as written, including all statutory requirements related to the protection and use of voter information.

As provided in Title 17, § 2154 of the Vermont Statutes Annotated, which governs the statewide voter checklist, Vermont law places clear limitations on the disclosure and use of voter checklist information. While the statewide voter checklist is a public record, current Vermont law strictly mandates that a voter's **full date of birth, Social Security number, driver's license number, telephone number, and email address** remain confidential and exempt from public inspection and copying under the Public Records Act. The law also includes restrictions on disclosure to federal agencies for certain purposes, such as comparing a voter's information maintained in the checklist to personally identifying information contained in other federal databases and publicly disclosing a voter's information for such purposes.

Vermont municipal clerks are the custodians of election records and voter information in our local communities. In that capacity, we administer and safeguard voter checklists in accordance with Title 17 of the Vermont Statutes Annotated. We join the Vermont Secretary of State in our commitment to faithfully carry out those duties regarding the voter checklist in a professional, nonpartisan manner, guided by Vermont statutes, applicable court orders, and any lawful directives.

As always, we remain committed to maintaining the integrity of Vermont's elections and the public trust placed in local election officials.
