The meeting will then be adjourned until Tuesday, March 4, 2025, for voting on Articles II-VIII by Australian Ballot.

To elect (3) School Directors, for two 3-year terms and one 1-year remaining term. See Town of Wilmington and Town of Whitingham results for March 4, 2025.

ARTICLE VI

Shall the voters of the Twin Valley Unified Union School District approve the School Directors to expend \$11,149,882 which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in per pupil education spending of \$14,261, which is 2.72% higher than per pupil education spending for the current year.


